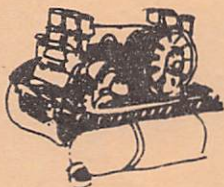

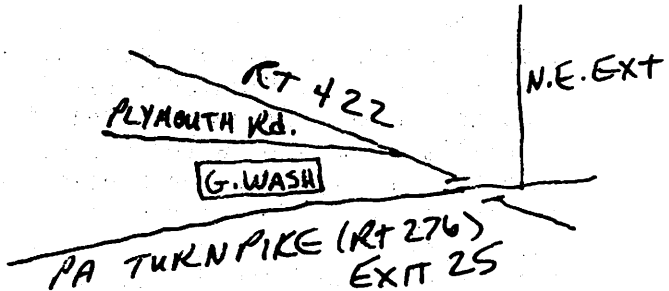

President's Message

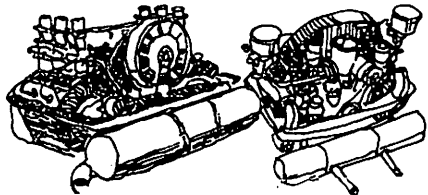

Notice is hereby given to the membership of the Riesentoter Region, Porsche Club of America that the following Amended Constitution and Bylaws will be presented for the purpose of enactment as stated, or enactment as modified, after discussion, at the August general meeting of the Riesentoter Region:

CONSTITUTION AND BYLAWS *

CONSTITUTION

Article I. Name

The name of the club will be the "Riesentoter Region, Porsche Club of America, Inc."

Article II. Objectives

The members of the club are joined together and are mutually pledged to the furtherance, and promotion, of the following:

A. The highest standards of courtesy and safety on the roads.

B. The enjoyment and sharing of good will and fellowship engendered by owning a Porsche and engaging in such social and other events and activities as may be agreeable to the membership.

C. The maintenance of the highest standards of operation and performance of the marque by sharing and exchanging technical and mechanical information.

D. The establishment and maintenance of mutually beneficial relationships with the Porsche factory, Porsche dealers, and service sources, to the end that the marque shall prosper and continue to enjoy its unique leadership position in sports car history.

E. The interchange of ideas and suggestions with other Porsche Clubs, with such cooperation as may be desirable by the membership.

F. The establishment of such mutually cooperative relationships, as may be desirable, with other sports car clubs.

Article III. Policy

A. The club will be politically non-partisan.

B. The club is empowered to conduct all business, on a non-profit basis, necessary to carry out the general purposes set forth in the Certificate of Incorporation and in this Constitution and Bylaws. Unless otherwise provided herein, the powers of the club will be in accordance with the laws of the Commonwealth of Pennsylvania for non-profit corporations.

C. All obligations incurred by the club will be incurred solely as corporate obligations. No personal liability whatsoever will be attached to or be incurred by any officer or member of the club, by reason of any corporate obligation or liability.

BYLAWS

Article I. Membership

A. Any person is eligible for membership as prescribed below herein.

B. Membership may be suspended or revoked by the Executive Board for conduct inconsistent with the objectives or policies of the club, or prejudicial to the good order and reputation of the club.

C. All members, except Riesentoter Region honorary members, must be members in good standing in the national Porsche Club of America, Inc.

Article II. Classes of Membership

A. Active Member: Any owner or co-owner, lessee or co-lessee, of a Porsche, who is 18 years of age or older, who has paid the required dues to national Porsche Club of America and who is in good standing therewith, is eligible for membership in the Riesentoter Region, Porsche Club of America, Inc.

B. Family-active Member: One other person of the active member's immediate family, 18 years of age or older, who is the wife, husband, brother, sister, son, daughter, mother, or father of the active member, is eligible to be a family-active member.

C. Associate Member: Any active member, who ceases to own or co-own a Porsche, but continues to pay dues to and remain in good standing with national Porsche Club of America, may continue membership. A person of the associate member's family, who has been a family-active member, may continue as a family-associate member.

D. Honorary Member: Any person who, on the affirmative vote of the Executive Counsel of national Porsche Club of America, or the Executive Board of Riesentoter Region, is deemed to merit recognition for outstanding interest in or service to the club, may be made an honorary member. Such membership will be limited to one year, but may, upon the affirmative vote of Executive Counsel of national Porsche Club of America, or the Executive Board of Riesentoter Region, be renewed or extended.

E. Life Member: Any person, who upon the vote of the Executive Counsel of national Porsche Club of America, is deemed to have performed extraordinary service to the club, is eligible to warrant this signal honor. All past national Presidents of Porsche Clubs of America.

F. Affiliate Member: Any person, 18 years of age or older, named by an active member at the time of joining or at any renewal of membership in lieu of a Family-Active Member.

G. Dual Member: Any person being a member of national Porsche Club of America, and another Region thereof, who files an application for dual membership with Riesentoter Region and simultaneously pays to Riesentoter Region the equivalent amount of money, as dues, as would be returned to Riesentoter by national Porsche Club of America for one year's membership.

Article III. Officers

A. The business and affairs of the club will be managed by the Executive Board, which will consist of a President, Vice-President, Secretary, Treasurer, Social Chairman, Technical Chairman, Competition Chairman, Membership Chairman, Publication Editor, and Past-President. The members of the Executive Board will be the officers of the club, and no member will hold more than one office at a time. Upon nomination, and approval by the general membership, there may be more than one person in any given position, but that position will have only one vote in the business and affairs of the Executive Board.

B. All members described in Article II, above, are eligible to hold office in Riesentoter Region.

C. In the event of a vacancy in the office of President, the Vice-President will assume the office of President. In the event of a vacancy in any other office, the Executive Board will fill such vacancy by appointment.

D. Failure of a member of the Executive Board to perform the duties of his office will be considered grounds for removal from his office. A written motion of removal must be published in the Riesentoter Regional publication. Removal will require a majority vote of the membership attending the next regular general meeting after publication.

E. The duties and responsibilities of the officers, and the rules and regulations governing events and activities, will be determined by the Executive Board.

Article IV. Elections

A. The nominating committee will consist of the President and the three most recent Past-Presidents, who are still members.

B. The nominating committee will present its slate of officers at the August meeting of the Club. Nominations from the floor will be accepted at the September meeting of the club, or in writing, to be received by the Executive Board prior to the September meeting, when all nominations will close.

C. The annual election will be held at the October meeting of the club. All members will be sent notice of the election and the candidates in a club publication prior to the October meeting. The officers will be elected at this meeting by majority vote, and they will hold office for one year, in accord with the fiscal year described herein, or until their replacement is selected as described in Article III, above.

Article V. Committees

The committees, necessary for the performance of the Club's business and affairs, will be established by the Executive Board. The Chairman of any Committee shall be appointed by the Executive Board.

Article VI. Meetings

A. A regular meeting for the membership will be held monthly. A banquet may be held in lieu of the November meeting. There will be no meeting held in December.

B. A quorum will be constituted by the membership present at any regular meeting.

C. All regular meetings will be conducted in general accordance with usual parliamentary procedure, as specified in Roberts Rules of Order.

Article VII. Accounts

A. Fiscal Year: The fiscal year of the club will begin on the first day of January and terminate on the thirty-first day of December.

B. Books: The books of record will be properly maintained to reflect financial receipts, disbursements, balances, assets, and liabilities of the club.

C. Audit: The books of the club will be audited annually by a Certified Public Accountant or an audit committee.

D. Financial Statement: At the next regular meeting or by club publication, following the annual audit of the books, the Treasurer will submit the financial statement of the club to the membership.

E. Funds: The funds of the Club will be deposited in a bank designated by the Executive Board.

F. Financial Orders: Checks and other orders for the payment of monies in the name of the club will be signed by the President and/or the Treasurer.

Article VIII. Amendments

Notice of proposed amendments to the Constitution or Bylaws must be presented to the membership in the Regional publication prior to the next certain regular meeting and the month of said meeting shall be stated in the Notice. The Constitution or Bylaws may be amended by a majority vote of the membership at said next regular meeting.

It's always a bit risky telling in print the stories that are sometimes narrated at our General Meeting. Nonetheless, I thought I heard Mr. Sechowicz say...

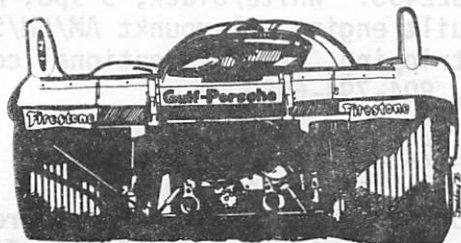
Axel Shield came out of his room in Richmond and found his green 911S sitting on one corner. Seems a torsion bar died and he covered a fair part of the city getting a replacement.
