Minutes of a Meeting of the Executive Board

April 28, 2019

The Executive Board of Riesentöter Region, Porsche Club of America, Inc., held a meeting on Sunday, April 28, 2019 at Osako, Lansdale, Pennsylvania. The voting members present were Jeffrey Walton, Margaret Nettleton, Wendy Walton, David Nettleton, Corey McFadden, and Marty Kocse; accordingly, a quorum was present at the meeting. The voting members absent were Roy Blumberg, Christopher Barone, and Graham Knight. Additionally present as the invitation of the Board was Beth McFadden.

Jeffrey Walton called the meeting to order at 6:20 PM. Previous minutes were approved and the Treasurer's report was accepted.

Jeff announced that the newly appointed Rally Chair has resigned due to relocation out of the area. He also confirmed the upcoming Street Survival programs on April 13th and June 15th. The first one is SCCA sponsored and the second is a RTR event. He has suggested to SCCA that a pre-event meeting needs to take place for drivers and instructors.

Next, Jeff discussed the Zone 2 meeting attended by himself and Roy Blumberg. Jeff had previously asked at the last meeting about the exclusion of Pete Stoudt from the Werks Reunion vendor area and asked again for an answer to his question. He also spoke to PCA President Tom Gorsuch about this issue.

Next, Corey McFadden reported on the RTR Foundation 2019 Raffle. To date, 40 tickets have been purchased. He will send out additional e-mail blasts to the membership.

He also announced the next membership meeting will be at Porsche of the Lehigh Valley on May 22, 2019. The new Macan will be previewed. The June membership meeting will be a picnic at the Valley Forge Volunteer Company grounds. Additionally, the next board meeting will be arranged by Marty Kosce.

Roy Blumberg reported the current membership numbers as follows – members- 1640, associate – 918, for a total membership of 2558.

Marty Kosce next reported that both Jefferson and Shenandoah DE events were profitable. Planning is under way for Pocono. Additionally, registration is open for all 2019 events. Implementation of the new HANS has begun with loaners available for drivers.

Yogi Fernandez was announced as the new Pit Marshal.

Marty also thanked Dave Hathaway for coordinating with the Pennsylvania State Police and Sunny Day Camp for a parade run with children from the camp.
