Minutes of a Meeting of the Executive Board

September 23, 2020

The Executive Board of Riesentöter Region, Porsche Club of America, Inc., held a meeting on Wednesday, September 23, 2020, via live conferencing. The voting members present were Jeffrey Walton, Wendy Walton, Margaret Nettleton, David Nettleton, Corey McFadden, Garrett Hughes, and Marty Kocse; accordingly, a quorum was present at the meeting. The voting members absent were Chris Barone, Roy Blumberg, and Brian Minkin. Also attending was John Gaydos. The meeting was called to order at 7:10 PM.

Upon a motion made by Jeff Walton and seconded by Corey McFadden, minutes from the previous meeting were unanimously accepted as amended.

Jeff Walton reported on his recent meeting with Philabundance and WMMR concerning Camp out For Hunger 2020 and Phila-A- Trunk. We will be staging in the Wells Fargo parking lot on November 15<sup>th</sup> with car clubs arriving at time spaced intervals. Riesentoter participants will meet at the Capitol Grille in King of Prussia and caravan down as in past years. Additionally, we will again have gift basket raffles with the proceeds going to the Valley Forge Volunteer Fire Company. Phila-A-Trunk this year will be a drive by, drop-off, and drive off event.

On October 3<sup>rd</sup>, the Octoberfest at Valley Forge Volunteer Fire Company grounds, which is the October membership meeting, has the possibility of a German band performing. A motion was made by Jeff Walton and seconded by Dave Nettleton to reallocate \$1600 in unspent funds from the 2020 Road Trip to cover the expense.

Wendy Walton next reported she would be meeting with Chester Valley Golf Club to discuss possible options for the 2020 Holiday Party. She also gave additional information on the Octoberfest including stoneware tankards for all attendees and raffle tickets for German gift baskets.

Garrett Hughes announced the next Der Gasser deadline is October 20<sup>th</sup>.

Dave Nettleton reported that the third Pocono Autocross event had over 70 drivers in attendance. The next races are at Ripken Field, Pocono, and Bader Field.

The next topic of discussion centered on a possible new award for the top finisher in PCA sponsored Sim Racing. Corey McFadden will explore the idea and award.

Marty Kocse next reported on Drivers Education. The first instructor event at Pocono was a success with no incidents. The tech for Summit will be at Porsche of Conshohocken. 140 drivers are expected at Summit Point. The event after Summit is at New Jersey Motor Park in November.

Corey McFadden announced that the Club Race at Monticello Motor Club is cancelled for 2020. We hope to reschedule for 2021. Travel restrictions and a change in date led to fewer participants.

The recent Rally was a success with 45 participants.

John Gaydos next informed that that will be no Street Survival sessions held at Montgomery County Community College through May 2021.
